Affordable Care Act: 2024 Compliance Checklist

The Affordable Care Act (ACA) made a number of reforms to group health plan coverage when it was enacted in 2010. Since then, changes have been made to various ACA requirements that employers should be aware of. These changes include annual cost-of-living increases to certain ACA dollar limits, extensions to ACA reporting deadlines and updates to preventive care coverage guidelines.

Changes to some ACA requirements will take effect in 2024 for employers sponsoring group health plans. Significantly, the affordability percentage under the ACA's employer mandate rules for applicable large employers (ALEs) will be at its lowest point for plan years beginning in 2024, which may require many ALEs to lower their employee contribution rates.

To prepare for 2024, employers should review these ACA requirements and develop a compliance strategy. Employers should ensure that their health plan documents, including the summary of benefits and coverage (SBC), are updated to reflect any new plan limits and that up-to-date information is communicated to employees at open enrollment time.

Plan Design Changes

The following plan design requirements have changed for 2024:

- Limits on cost sharing for essential health benefits
- · Coverage affordability percentage under the employer mandate rules
- Dollar amounts for calculating penalties under the employer mandate rules

Reporting Deadlines

The following deadlines apply for reporting under Sections 6055 and 6056:

- April 1, 2024: Electronic IRS returns for 2023 must be filed by this date.
- March 1, 2024: Individual statements for 2023 must be furnished by this date.
- Feb. 28, 2024: Paper IRS returns for 2023 are due by this date.

PLAN DESIGN CHANGES	
Overall Cost-sharing Limits	Complete
Confirm that your plan's out-of-pocket limit for essential health benefits (EHB) does not exceed the ACA's limit for the plan year beginning in 2024.	
Effective for plan years beginning on or after Jan. 1, 2024, a health plan's out-of-pocket limit for EHB may not	

	exceed \$9,450 for self-only coverage and \$18,900 for family coverage. This limit applies to all non-parameters group health plans, including fully insured and self-funded plans. Any out-of-pocket expenses equired by or on behalf of an enrollee with respect to EHB must count toward the cost-sharing limit. This includes deductibles, copayments, coinsurance and similar charges but excludes premiums and spending for concovered services. Also, plans that use provider networks are not required to count an enrollee's expenses or out-of-network benefits toward the ACA's cost-sharing limit.
	f you have a health savings account (HSA)-compatible high deductible health plan (HDHP), keep in mind hat the plan's out-of-pocket maximum must be lower than the ACA's limit. For 2024, the out-of-pocket naximum for HDHPs is \$8,050 for self-only coverage and \$16,100 for family coverage.
mplete or N/A	Health Flexible spending Account (FSA) Limits
	f you have a health FSA, confirm that its dollar limit on employees' salary reduction contributions will not exceed the adjusted limit for the plan year beginning in 2024 (once this limit is released by the IRS).
	The ACA imposes a dollar limit on employees' pre-tax contributions to a health FSA. This limit is indexed each year for cost-of-living adjustments. An employer may set their own dollar limit on employees' ontributions to a health FSA, as long as the employer's limit does not exceed the ACA's maximum limit in effect for the plan year. For plan years beginning in 2023, the health FSA limit is \$3,050. The health FSA limit has not been released yet for plan years beginning in 2024.
	f you have a health FSA that allows carryovers of unused amounts, confirm that the maximum inused amount from a plan year starting in 2024 that is allowed to be carried over to the immediately ollowing plan year beginning in 2025 does not exceed the adjusted limit (once this limit is released by the IRS).
	or plan years beginning in 2023, the health FSA carryover limit is \$610 . The carryover limit for plan years beginning in 2024 has not been released yet.
omplete	First-dollar Preventive Care Coverage
	Confirm that your health plan covers the latest recommended preventive care services without mposing any cost sharing.
	Ion-grandfathered health plans must cover certain preventive health services without imposing cost-sharing equirements (i.e., deductibles, copayments or coinsurance) for the services. Health plans are required to djust their first-dollar coverage of preventive care services based on the latest preventive care ecommendations. More information on the recommended preventive care services is available rom HealthCare.gov .
	mpact of Ongoing Litigation: Currently, a key portion of the ACA's preventive care mandate is the subject of an ongoing legal dispute. On March 30, 2023, the U.S. District Court for the Northern District of Texas culed that preventive care coverage requirements based on an A or B rating by the U.S. Preventive Services cask Force (USPSTF) on or after March 23, 2010, violate the U.S. Constitution and blocked enforcement of those requirements. However, the 5th Circuit Court of Appeals put enforcement of the District Court's ruling on hold pending the case's appeal. It is uncertain whether the District Court's ruling will be reversed or apheld by the 5th Circuit. For now, non-grandfathered health plans and issuers should continue to cover, without cost sharing, the full range of preventive care services required by the ACA, including items or envices that have an A or B recommendation by the USPSTF.
mplete or N/A	Excepted Benefit Health Reimbursement Arrangement (HRA)
	f you offer an excepted benefit HRA, confirm that its maximum benefit amount for the plan year beginning in 2024 does not exceed \$2,100.
	mployers with traditional group health plans may offer a limited benefit HRA that is exempt from the ACA's narket reforms. This HRA, called an excepted benefit HRA, can be used to reimburse employees' eligible nedical care expenses, up to \$1,800 each year, as adjusted by the IRS for inflation. For 2024, this maximum mit is \$2,100.
mplete or N/A	Grandfathered Plan Status
	mployers with traditional group health plans may offer a limited benefit HRA that is exempt from the ACA's narket reforms. This HRA, called an excepted benefit HRA, can be used to reimburse employees' eligible nedical care expenses, up to \$1,800 each year, as adjusted by the IRS for inflation. For 2024, this maximum mit is \$2,100.

Grandfathered plans are exempt from some of the ACA's mandates. A grandfathered plan's status will affect its compliance obligations from year to year. Here are some additional points to keep in mind:

- If a plan will lose its grandfathered status for 2024, confirm that the plan has all of the additional patient rights and benefits required by the ACA for non-grandfathered plans. This includes, for example, coverage of preventive care without cost-sharing requirements.
- If a plan will keep its grandfathered status, continue to provide the Notice of Grandfathered Status in any plan materials provided to participants and beneficiaries that describe the benefits provided under the plan (such as the plan's summary plan description and open enrollment materials). A model notice is available from the Department of Labor (DOL).

/ill you be an ALE for 2024?		
he ACA's employer mandate rules apply only to ALEs. ALEs are employers with 50 or nore full-time employees (including full-time equivalent employees) on business days during he preceding calendar year. Employers determine each year, based on their current number f employees, whether they will be considered an ALE for the following year.		
nder the ACA's employer mandate rules, ALEs are required to offer affordable, minimum alue (MV) health coverage to their full-time employees (and dependent children) or pay a enalty. An ALE will be subject to penalties if one or more full-time employees receive a ubsidy for purchasing health coverage through an Exchange. An individual may be eligible or an Exchange subsidy either because the ALE does not offer coverage to that individual, or ffers coverage that is unaffordable or does not provide MV.		
you answered "no," you can stop completing this section of the checklist. Because your ompany is not an ALE for 2024, the ACA's employer mandate rules do not apply.		
Offer of Health Plan Coverage	Yes	No
o you offer health coverage to your full-time employees?		
o correctly offer coverage to full-time employees, ALEs must determine which employees are all-time employees under the ACA's definition. A full-time employee is an employee who is employed, on average, at least 30 hours of service per week (or 130 hours of service in a falendar month).		
ne IRS provides two methods for determining full-time employee status for purposes of ffering coverage: the monthly measurement method and the look-back measurement method.		
you answered "no," your company will be subject to penalties if one or more of your full-time mployees receives a subsidy to purchase health coverage through an Exchange.		
your health plan coverage affordable?		
ealth plan coverage is considered affordable if the employee's required contribution to the lan does not exceed 9.5% of the employee's household income for the taxable year (as djusted each year). The affordability test applies only to the portion of the annual premiums or self-only coverage and does not include any additional cost for family coverage. Also, if an employer offers multiple health coverage options, the affordability test applies to the lowest-option that provides MV.		
ecause an employer generally will not know an employee's household income, the IRS has rovided three optional affordability safe harbors that ALEs may use to determine fordability based on information that is available to them: the Form W-2 safe harbor, the stee of pay safe harbor and the federal poverty level safe harbor.		
or plan years beginning in 2024, the adjusted affordability percentage is 8.39% . This is a ubstantial decrease in this percentage and is the lowest this percentage has ever been set (at nore than 1% below the statutory affordability percentage of 9.5%). As a result, many		

employers may have to significantly lower the amount they require employees to contribute for 2024 to meet the adjusted percentage.	
If you answered "no," your company will be subject to penalties if one or more of your full-time employees receives a subsidy to purchase health coverage through an Exchange.	
Does your health plan coverage provide MV?	
A health plan provides MV if the plan's share of the total allowed costs of benefits provided under the plan is at least 60% of those costs. Three approaches may be used for determining MV: an MV calculator, design-based safe harbor checklists or actuarial certification. In addition, any plan in the small group market that meets any of the "metal levels" of coverage (i.e., bronze, silver, gold or platinum) provides MV.	
In addition, plans that do not provide inpatient hospitalization or physician services (referred to as non-hospital/non-physician services plans) do not provide MV.	
If you answered "no," your company will be subject to penalties if one or more of your full-time employees receives a subsidy to purchase health coverage through an Exchange.	
Possible Penalty Amounts	Complete or N/A
If your company may be liable for an ACA penalty, calculate the possible penalty amount.	
Depending on the circumstances, one of two penalties may apply under the ACA's employer mandate rules: the 4980H(a) penalty or the 4980H(b) penalty. Here's an overview of these penalties:

Is your company subject to ACA reporting under Code Sections 6055 or 6056?		
The following employers are subject to ACA reporting under Internal Revenue Code (Code) Sections 6055 and 6056:		
 Employers with self-funded health plans (Section 6055 reporting) ALEs with either fully insured or self-funded health plans (Section 6056 reporting) 		
Employers who are not ALEs and have fully insured health plans are not subject to these ACA reporting requirements.		
Employers subject to this reporting must file certain forms with the IRS each year and provide annual statements to individuals who are covered under the health plan (under Section 6055) and each of the ALE's full-time employees (Section 6056). Note that ALEs with self-funded plans are required to comply with both reporting obligations. However, to simplify the reporting process, the IRS allows ALEs with self-funded plans to use a single combined form to report the information required under both Sections 6055 and 6056.		
If you answered "no," you can stop completing this section of the checklist, as your company is not subject to ACA reporting under Sections 6055 or 6056.		

File Returns with IRS by Applicable Deadline in 2024	Complete
For the 2023 calendar year, file electronic returns with the IRS by April 1, 2024.	
Under Code Section 6055, reporting entities will generally file Forms 1094-B (a transmittal) and 1095-B (an information return). Under Code Section 6056, entities file Forms 1094-C (a transmittal) and 1095-C (an information return). Employers reporting under both Sections 6055 and 6056 (i.e., ALEs with self-funded plans) use a combined reporting method by filing Forms 1094-C and 1095-C.	
The normal deadline for electronic ACA reporting is March 31 each year. However, since March 31, 2024, is a Sunday, electronic returns must be filed by the next business day, which is April 1, 2024 .	
Reporting entities may receive an automatic 30-day extension to file with the IRS by completing and filing Form 8809 (Application for Extension of Time To File Information Returns) by the due date of the returns.	
Paper Reporting : Before 2024, employers who filed fewer than 250 individual statements under Sections 6055 or 6056 could file their ACA returns on paper. However, beginning in 2024, paper filing is only available to employers who file fewer than 10 information returns with the IRS for the year. This means that only the smallest employers will be able to file using paper returns in 2024. For these employers, the deadline to file ACA paper returns is Feb. 28, 2024 .

	Provide Individual Statemetns by Applicable Deadline in 2024

Complete

For the 2023 calendar year, provide individual statements by March 1, 2024.

Written statements must be provided to individuals within 30 days of Jan. 31, 2024. Because 2024 is a leap year, the deadline for individual statements is March 1, 2024.

PATIENT-CENTERED OUTCOMES RESEARCH INSTITUTE (PCORI) FEES	
Pay PCORI Fees (Self-funded Plans only)	Complete or N/A
Pay PCORI fees by July 31, 2024, for plan years ending in 2023.	
Under the ACA, employers with self-funded plans must pay PCORI fees each year. These fees are reported and paid using IRS Form 720 (Quarterly Federal Excise Tax Return). For fully insured plans, the health insurance issuer is responsible for reporting and paying these fees.	
PCORI fees are due each year by July 31 of the year following the last day of the plan year. For plan years ending in 2023, the PCORI fee payment is due July 31, 2024.	
For plan years ending on or after Oct. 1, 2022, and before Oct. 1, 2023, the PCORI fee amount is \$3 per covered life. The IRS has not yet announced the PCORI fee amount for plan years ending on or after Oct. 1, 2023.	

DISCLOSURE REQUIREMENTS	
SBC Considerations	Complete
Provide an updated SBC in connection with the plan's open enrollment period for 2024.	
Health plans and issuers must provide an SBC to applicants and enrollees to help them understand their coverage and make coverage decisions. The SBC should be included with the plan's enrollment materials. If coverage automatically renews for current participants, the SBC must generally be provided no later than 30 days before the beginning of the new plan year.	
The SBC must follow strict formatting requirements. Federal agencies have provided <u>templates and related materials</u> , including instructions and a uniform glossary of coverage terms, for health plans and health insurance issuers to use. It should be updated before the plan's open enrollment period to reflect any changes in coverage for the upcoming plan year.	
For self-funded plans, the plan administrator is responsible for providing the SBC. For insured plans, both the plan and the issuer are obligated to provide the SBC; however, this obligation is satisfied for both parties if either one provides the SBC. Typically, the issuer will prepare the SBC for an insured health plan, although the employer may need to provide it to employees.	
Employee Notice of Exchange	Complete

Provide all new hires with a written notice about the ACA's health insurance Exchanges.	
The DOL has provided model Exchange notices for employers to use, which require some customization.	
Notice of Patient Protections	Complete or N/A
Provide a Notice of Patient Protections if your health plan requires participants to designate a participating primary care provider.	
Under the ACA, group health plans and issuers requiring the designation of a participating primary care provider must permit each participant, beneficiary and enrollee to designate any available participating primary care provider (including a pediatrician for children). Additionally, plans and issuers providing obstetrical/gynecological care and requiring the designation of a participating primary care provider may not require preauthorization or referrals for obstetrical/gynecological care.	
If a health plan requires participants to designate a participating primary care provider, the plan or issuer must provide a notice of these patient protections whenever the summary plan description (SPD) or similar description of benefits is provided to a participant. If a plan is subject to this notice requirement, it should be confirmed that it is included in the plan's open enrollment materials. Model language is available from the DOL.	
Grandfathered Plan Notice	Complete or N/A
If you have a grandfathered plan, make sure to include information about the plan's grandfathered status in plan materials describing the coverage under the plan, such as SPDs and open enrollment materials.
